- **Legal Name:** World Wildlife Fund Canada

- **Suggested wording for a residual gift:** "To pay WWF-Canada the residue (or share of the residue) of my Estate for such use and purpose as the Board of Directors may determine."
- **Suggested wording for a specific gift:** "To pay WWF-Canada the sum of \$\_\_\_ for such use and purpose as the Board of Directors may determine."
