# **Leave Your Legacy**

Leaving a charitable gift as part of your estate plan to help the people and families served by Providence Health Care ("PHC") through its acute care hospitals, centres, residences, and other facilities, including St. Paul's Hospital, provides the satisfaction of knowing you have made a truly meaningful contribution to future generations.

# What is a gift in will?

A gift in will is an effective way to create a lasting legacy of caring that will live on to support future generations.

Other benefits of making a gift in will:

- Make a gift without impacting your current finances; and
- Obtain a charitable tax receipt for your estate.

Types of gifts in will:

- Gift of Residue: Give a percentage of the residue (total assets less taxes, debts & cash bequests) of your estate;
   and
- Specific Bequest: Set aside a certain dollar amount or a specific piece of property such as an investment account or a particular stock.

#### What to do next

As part of making your will, or revising an existing will, you will likely meet with a lawyer or a notary public. In order to leave a charitable gift through your will, it is important that you include the full legal name of the charity.

The paragraphs below provide sample language which may be helpful to you and your lawyer as you make or revise your will.

#### Residual Bequest for future greatest needs:

#### Bequest of a specific amount for future greatest needs:

I give to St. Paul's Foundation of Vancouver the sum of \$\_\_\_\_\_ from my estate to be used for its greatest needs.

**Note**: While a gift for our greatest needs allows us to direct your gift to the priority needs of PHC at the time your estate gift is received; if you prefer to designate your gift to a specific program, please discuss your wishes with us so as to ensure your intentions are clearly communicated.

As well, since it is difficult to predict future circumstances, we recommend you include the following "power to vary" paragraph in your Will.

### Power to Vary:

If in the opinion of the Board of Directors of St. Paul's Foundation of Vancouver, it should become impossible, inadvisable, or impractical to use this gift for the specified purposes indicated in this my will, then the Board may in its discretion use the gift in the best interests of the hospitals, residences and other facilities operated by Providence Health Care, keeping in mind my original wishes.
