



# Sample Bequest Wording

For CRA purposes we file under:

Toronto East Health Network Foundation, and operate as  
Michael Garron Hospital Foundation  
CRA registration number 119259448 RR 0001

---

A **Residual Bequest** designates whatever remains of your estate after all debts, taxes, expenses, and all other bequests to your beneficiaries (including family and friends) have been fulfilled.

Example:

“I give, devise and bequeath to TORONTO EAST HEALTH NETWORK FOUNDATION, operating as MICHAEL GARRON HOSPITAL FOUNDATION bearing registration number 119259448 RR 0001, all ( or \_\_\_%) of the rest, residue, and remainder of my estate.”

---

An **Unrestricted Bequest** permits you to direct your gift to the area of greatest need.

Example:

“I give, devise and bequeath to TORONTO EAST HEALTH NETWORK FOUNDATION, operating as MICHAEL GARRON HOSPITAL FOUNDATION bearing registration number 119259448 RR 0001, the sum of \$..... (or .....%, or specific property (real estate, securities, etc.)) to be applied by to the areas of greatest need.”

A **Restricted Bequest** permits you to direct your gift towards a specific purpose.

Please keep in mind that your gift may be realized many, many years from now and some hospital departments or programs may no longer be operating. We recommend that you use as broad wording as possible and we can assist you.

Example:

“I give, devise and bequeath to TORONTO EAST HEALTH NETWORK FOUNDATION, operating as MICHAEL GARRON HOSPITAL FOUNDATION bearing registration number 119259448 RR 0001, the sum of \$..... (or .....%, or specific property (real estate, securities, etc.)) to be used for the following purpose:

A **Contingent Bequest** takes place only if specific individuals do not survive you.

Example:

“If (name/s of beneficiaries) does not survive me, or shall die within 90 days from the date of my death, then I give to TORONTO EAST HEALTH NETWORK FOUNDATION, operating as MICHAEL GARRON HOSPITAL FOUNDATION bearing registration number 119259448 RR 0001, all of my estate.”
