Gift in Your Will

Thank you for considering a gift in your Will to London Public Library. Every gift makes a difference no matter how large or small.

- With a bequest in your Will, you can create a future gift of a percentage of your estate or a specific amount of money
- There is no immediate cost to you so you don't have to worry that the gift will reduce what you have to live on
- You can make a bigger gift than you could give during your lifetime
- Gifts made in the Will can reduce or even eliminate final income tax that would otherwise reduce what you leave to your heirs

Gift of RRSP/RRIF

By designating London Public Library as the beneficiary of your retirement funds you will receive a charitable tax receipt to offset any taxes owed. The gift would go directly to charity without being taxed.

Gift of Appreciated Securities

Donate appreciated securities such as stocks and bonds and eliminate capital gains taxes as well as benefit from a charitable tax receipt. This is one of the most tax effective ways to make a charitable donation. To make a gift of securities, please contact the London Public Library for a Transfer Form.

Gift of Life Insurance

Giving a gift of life insurance is another way to make a gift with tax benefits. There are several ways to do this. For more information, contact Carla Rogers (see contact information below).

Sample Gift Language for Your Will

Your Will can reflect your commitment to London Public Library. The following sample bequest language options should help you establish a legacy that best suits your needs and wishes.

Example 1
I direct my Executors to give% of the residue of my Estate to London Public Library for use for highest priority needs as determined by the Directors of London Public Library.
Example 2
I direct my Executors to give to London Public Library the sum of \$ to be used for highest priority needs as determined by the Directors of London Public Library.
Example 3
I direct my Executors to give to London Public Library the sum of \$ (or% of my residue) to be used for the purpose of (examples could include: enhanced collections, programs and services, education or branch enhancements), provided that if such a purpose ceases to exist or ceases to be provided by London Public Library, then the legacy shall not fail but the Directors of London Public Library shall use such a legacy for a purpose which most closely resembles the purpose set out above.
Example 4
I direct my Executors to give to London Public Library (real estate, securities, etc.) for use where it is needed most as determined in the absolute discretion of the Directors of London Public Library.
